a)*Issues with academic integrity*

Because ChatGPT can produce outputs in response to different prompts supplied by users (students, for example), it may be used unethically, or in violation of the standards of academic honesty. Artificial intelligence (AI) used to generate a response or article could result in plagiarism if it is not disclosed (Kleebayoon & Wiwanitkit, 2023) or if the sources are not correctly credited (Thurzo et al., 2023). Academic misconduct and dishonesty that could ultimately harm students' academic progress could arise from assignments where students neglect to reference the sources generated by chatbots.

Inequitable evaluation of learning *b*)

The usage of ChatGPT and other AI-generated tools may lead to biased evaluations, which raises questions about how students' work is assessed. According to studies conducted thus far, it may be difficult to discern between ChatGPT's and humans' textual outputs (Cotton et al., 2023; Else, 2023; Shiri, 2023). Mhlanga (2023) said that teachers were worried that students would use ChatGPT to outsource their tasks because of its speedy generation of relevant essays. As a result, students who create their assignments, homework, or projects using this sophisticated tool have a greater chance of earning better grades than their peers. However, according to a study by Taecharungroj (2023, p. 6), "one user reported students using ChatGPT to write a school essay and then taking credit for the resulting A+ grade, while another found that ChatGPT passed a practice bar exam with a score of 70% (35/50)." This is noteworthy. In order to prevent biased evaluation, this should be taken into consideration since it is conceivable that it could have a detrimental emotional influence on students and the reputation of educational institutions.

Overuse of artificial intelligence c)

Excessive use of ChatGPt is harmful for students. It may happen that student get completely dependant of CHATGPT to comlete his work this may lead to reduction in analytical thinking and decision making ability as everything will be available so easily to them, especially those who complete their work at last minute. According to Cotton et al. (2023), students should be required to apply their analytical, critical, communication, and problem-solving skills in the upcoming evaluation.

Additionally, formative assessment should be used more often than summative evaluation by creating interesting tasks that force students to present, argue, engage in group discussions, and collaborate (Cotton et al., 2023). If a final report is used as the main evaluation, students must also prepare academic papers with citations, references, and a clear context.

Thirdly, it is imperative that educational establishments create and distribute training materials to instructors and students so they may utilize ChatGPT effectively while upholding academic integrity through ethics and accountability. This suggests that rather than outlawing the use of ChatGPT, there ought to be instruction or guidelines on the efficient use of this AI instrument for learning and scientific endeavors.

Fourth, action research should be carried out to further investigate the efficacy and efficiency of integrating this intelligent application in education in order for schools and universities to improve the quality of instruction. To enable academics to look into ways to make the most of ChatGPT for educational purposes, more money should be made available for studies into the application of AI tools like ChatGPT for research and teaching.

Fifth, it is advised that students exercise caution when using ChatGPT to provide them with various forms of support. To ensure accuracy, it could be helpful for students to review, evaluate, and change the results produced by this AI program. Students should first familiarize themselves with the application's advantages and disadvantages, bearing in mind the consequences of academic dishonesty and the rules governing academic integrity (Rudolph et al., 2023).

Lastly, it is recommended that scholars begin using ChatGPT to gain a deeper understanding of its benefits and drawbacks for scholarly work. In order to avoid deliberate or inadvertent academic misconduct, this tool should only be used for brainstorming and outlining—not for writing complete research papers. That being said, it is crucial to make sure that all of the data produced by this tool for idea generation is accurate by reviewing and revising it and by sending out follow-up prompts to get further responses. Otherwise, using ChatGPT could be more of a burden than a benefit.




Figure 1 Role of Legal Awareness in Women Empowerment
