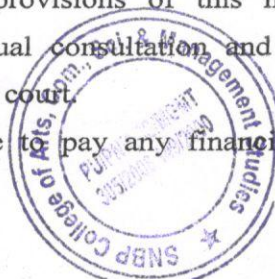
Either party may discontinue this by giving one month prior notice in writing to the other party explicitly mentioning the reason there of dishonoring any commitment made prior to the date of termination notice.

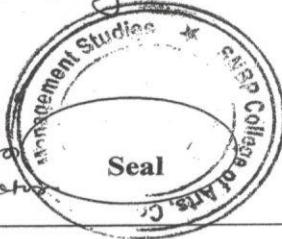
