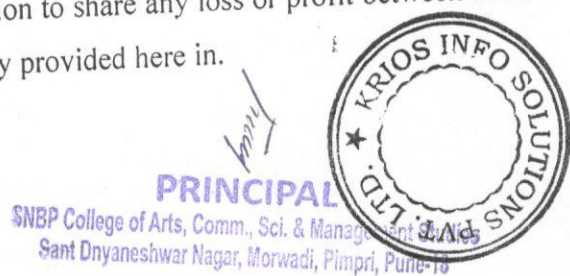

6. Understanding and Amendment






