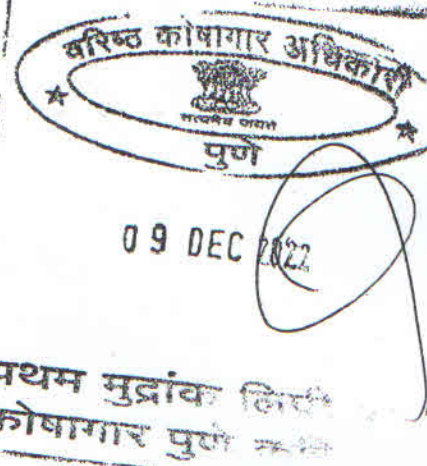

## **Background**

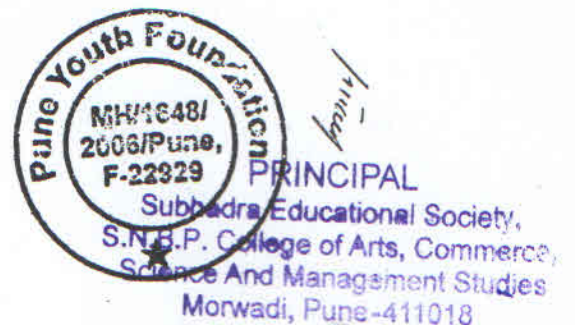
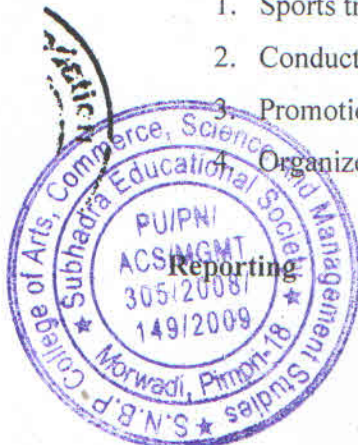

**Financial Consideration:**



Nothing in this MOU shall be deemed to be a commitment or obligation of funds from the both the parties or any of their various components. If any special financial consideration will there that will be take separately.

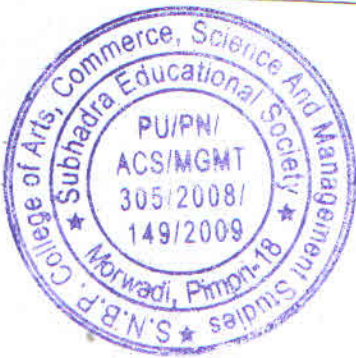
**Duration**
