Taking into account the terms of the Agreement on Coaching, Practice and support for the various sports between the Rovers Academy, Pune and the Department of Physical Education, SNBP College of Arts Commerce Science & Management Studies, Morwadi, Pimpri Signed on 11/01/2019.

Acknowledging the role of bilateral sports cooperation as a factor reinforcing the ties of friendship and of mutual enhancement; Reiterating their common desire to contribute to the building of a better and more peaceful 'World of favoring the practise of sports by men and women, such as the education of the youth through the practice of-an indiscriminate sport in a spirit of mutual understanding, of solidarity and of fait-play;

### Article 1. Fields of cooperation

#### Article 2. Forms of cooperation

The cooperation between the Parties is implemented as follows:

- Exchange of information and experiences
- Exchange of publications and research
- Organization of workshops and participation in training camps;
- > Joint organization of seminars and conferences and all other initiative of mutual interest;

## Article 3. Financing of the Exchanges

Nothing in this MOU shall be deemed to be a commitment or obligation of funds from either SNBP College of Arts, Commerce Science & Management Studies, Morwadi, Pimpri, Pune or Rovers Academy, Pune.

#### A icle 4. Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from SNBP College of Arts, Commerce Science & Management Studies, Morwadi, Pimpri, Pune and the Rovers Sport Academy, Pune. This MOU will take effect on and will be valid for Five (5) years from the date noted in the first line of this document. This MOU will remain in effect until modified or terminated by any one of the partners by mutual consent. Each Institution will have copies of this agreement.
